To the Canadian Federation of Students - Quebec Component,

On July 4th, 2007, I, Angelica Novoa, in my capacity as president and representative of the Board of Directors of the Concordia Student Union, a full member of the Canadian Federation of Students - Quebec Component, forwarded an e-mail to you directing you to that call a special general meeting in accordance with by-law 3.3 of the Quebec Component's by-laws due to the serious doubts concerning the validity of the election that took place on June 19th, 2007. Such meeting is to be scheduled for no later than July 25th, 2007, in order for the Provincial executive no to be in contravention of the Quebec Component's by-laws.

In said e-mail I cautioned you not to transfer power to yourselves, the impugned board members, Nina Amrov and Mahdi Altalibi, given the likelihood that any actions or steps taken by you in such capacity would be invalidated as well. In light of the fact that you completely disregarded my warnings, I am, by these presents, notifying you that the Concordia Student Union view you as liable for any and all damages that may result from your refusal to retain power until such time as the validity of the election could be ascertained by way of special general meeting.
