- adequate common social areas, in both size and quality of service;
- accessible affordable good quality food service;
- accessible affordable supplies;
- presence on site of an ombudsperson, or other accessible confidential counselling service;
- health services;
- accessible information systems, information and communication;
- adequate distribution of information on decisions and implementation timelines:
- representation and input in all decision-making, including implementation;
- free and accessible child care:
- adequate and accessible harassment and grievance processes and the right to appeal;
- a suitable and safe physical plant."

In addition, regressive aspects of the social assistance and unemployment insurance programs are echoed in the student loan program: the clawback of assistance based on employment income earned while receiving assistance is present in all three programs. Therefore, in solidarity with individuals receiving all forms of government assistance, the Federation:

- Opposes the stereotype of those on forms of assistance as lazy or inferior and recognises that widespread poverty is a direct result of our economic system;
- Opposes the claw back of assistance based on earnings while receiving assistance through government social programs; and
- Opposes the deliberate setting of assistance at levels well below the lowincome cut off rates determined by the National Council on Welfare.

C. Student Poverty and Student Health

The Federation:

1997-98 CAMPAIGNS STRATEGY

FIRST COMPONENT

Campaign against Income Contingent Repayment Schemes

CONTEXT

Following the Federation's massive January 25th, 1995 mobilization in response to the government's proposed social policy review, the federal government dropped its interest in income contingent loan repayment schemes.

Yet In the federal budget announced on February 18, 1997, the Liberals announced they would "investigate the possibility of offering income sensitive repayment schemes as an option with interested provincial governments."

There are a few possible reasons for which the budget announcement contained this regressive funding model. First, the Federal Liberals have been lobbied strongly by the Conservative government in Ontario to implement the scheme so that this provincial government can fulfill its 1995 campaign promises. The Federal government has apparently renewed its interest in the scheme in exchange for Ontario's agreement to increase Canada Pension Plan premiums. Secondly, many university presidents continue to lobby for the implementation of ICLRPs in order to create greater flexibility to raise tuition fees. As well, from the perspective of the Federal government, if the government could come up with a self-financing program it could eliminate its expenditures on interest payments for in-course students and interest relief for students in repayment and defaults on the remaining government guaranteed loans. Thirdly, the government could appear to be responding to concerns about decreasing accessibility while at the same time allowing for more rapid deregulation of fees at the provincial and institutional level, thereby decreasing the demand on federal dollars.

At this time, the average debtload per student in Canada is now higher than that of a student in the United States. The Federation remains committed to debt reduction with the eventual goal of the creation of a national system or grants. The budget announcement clearly frustrates this goal: the inclusion of income Contingent Loan Repayment Schemes seems to be intended to justify further increases in student debt as somehow more 'manageable.' In fact, the prospect of increased debt itself is a barrier to pursuing a post-secondary education.

The liberal government has tacitly admitted by way of its election platform that grants, at least strategic ones, resonate more clearly with Canadians than Income Contingent Repayment Schemes. Yet the pressure to implement an asymetrical form of the scheme across the country is strong.

The Federation is committed to bringing much stronger and more effective pressure to bear on the government to drop income contingent loan repayment schemes in any form.

CAMPAIGN GOALS

- a. Ensure that Income Contingent Loan Repayment Schemes are eliminated as a public policy option:
- b. Convince key provinces to express their unwillingness to participate in an Income Contingent Loan Repayment Scheme;
- Target the banks' involvement in the implementation of Income Contingent Loan Repayment Schemes;

- d. Target the role that college and university presidents continue to play in promoting an Income Contingent Loan Repayment Scheme to governments, banks and the public;
- e. Inform parents of the dangers posed by Income Contingent Loan Repayment Schemes to the education of their children;
- f. Expand the "Special Opportunities Grants" by promoting a "Canada Student Grants Program."
- g. Secure changes to the Canada Student Loans Program to include: flexible repayment options; improvements to the needs-assessment formula, better rules for an appeal process and an indexation formula such as a "Student Cost of Living Index."
- h. Create a student aid website to give and receive information from members on debtloads and problems in receiving or repaying their loans.

IMPLEMENTATION

1. Federal-Provincial Congruency

Provincial components will be strongly encouraged to implement and further develop the campaign at the component level, during the respective component meetings that follow the adoption of this strategy.

2. Research

- a. Compromising Access, the Federation's seminal research document on the history and negative implications of ICLRP's, will be updated by September 1, 1997.
- b. A critical analysis of the federal government's current agreements with the banks and credit unions who are profiting from the disbursement of the CSLP will be undertaken
- c. An analysis of the positions of the federal political parties and provincial governments will be completed and sent out to the membership in conjunction with the revised *Compromising Access*.

3. Contact with Government

- a. Compromising Access will be sent to provincial and federal Members of Parliament;
- b. Those provincial governments which have previously expressed a resistance to Income Contingent Repayment Schemes will be called on to renew their commitment;
- c. A co-ordinated lobby strategy will be undertaken at the local and national level during the autumn term;
- d. Meetings will be held with the leadership of the major federal parties at the national level to discuss the role they can/should/will play in opposing the implementation of ICLRP's in any form This lobby effort will follow the release of the revised Compromising Access and precede the national day of action:
- e. Human Resources Development Canada will be lobbied to make improvements to the needs assessment formula, the appeals process, to create an indexation formula, and to further expand their Special Opportunities Grants.

4. Membership Mobilization

A post-card campaign, directed at the presidents of the five major banks, will be undertaken. Members will let the banks know that if they do not express their lack of interest in Income Contingent Repayment Schemes, students and local unions will close their accounts and withdraw their funds.

A mass mobilization will be held across the country on one day in March. The focus of the action will be to make clear to the the government and the public at-large that students are not interested in the kind of post-secondary education system that will arise from the implementation of ICRP's.

5. National Awareness & Media Strategy

The membership will be educated through posters, flyers and a media/lobby kit for member locals.

A national advertising campaign will be undertaken in the week preceding the national day of action, in campus and community newspapers and radio stations, and on the worldwide web.

A Student Aid web-site will be created to serve the following purposes:

- a. to give students information on their rights with respect to student loans, specifically on appeal amounts, options for flexible repayment, dealing with collection agencies, and fees associated with loans servicing;
- b. to collect quantitative and anecdotal information on student debt-loads, appeals and repayment concerns

6. Coalition Work

Work will be undertaken to revive the national Coalition for Post-Secondary Education.

Coalition partners in the social justice and labour sectors will be presented the federation's position and strategy on student aid and student debt, and will be asked to help in our campaign in a number of ways: circulating educational materials to their members, making financial or in-kind contributions to our national awareness and media strategy; participation in our lobby agenda, and monetary and non-monetary support for the mass mobilization.

SECOND COMPONENT

The Post Secondary Education Act/Agreement

CONTEXT

The Federation is committed to a system of post-secondary education free from all user fees. But what would such a system look like? The answer is to look to the way health care is funded in Canada. By modeling federal funding of universities and colleges on the way the federal government funds and regulates hospitals and clinics, the Canadian Federation of Students can present a credible and viable public policy option.

The Second Campaign will therefore promote an Act/Agreement that embodies the principles of the Canada Health Act, also recognizing the unique historical experience of Québec and First Nations.

CAMPAIGN GOALS

- 1. Implementation of the Act/Agreement as outlined by Federation policy.
- 2. Convincing the Federal government/Council of Ministers of Education-Canada that it still has a role to play in ensuring a more accessible system of post-secondary education.

IMPLEMENTATION

1. Federal-Provincial Congruency

The provincial/territorial components will be encouraged to implement the campaign at their levels especially for jurisdictional reasons;

2. Research

a. A framework of the Act/Agreement will be available to the membership following the May 1997 national general meeting. A draft of the Act/Agreement will be created and presented to Members of Parliament, members of provincial legislative assemblies, Québec's National Assembly, and the Assembly of First Nations.

3. Contact with Government

Face-to-face contact with federal Members of Parliament and provincial representatives will be organized;

4. National Awareness & Media Strategy

- The Membership will be educated through posters, flyers, national media work, and a media/lobby kit for member-locals;
- b. The general public will be educated through post-cards and/or letter-writing strategies and national media work.

5. Coalition work

Federation coalition partners will be educated on the issue and will be encouraged to defend and advocate the principles of the Act.

As part of this effort, the Canadian Federation of Students could seek a declaration that Canada has breached this obligation under international law. The best recourse available would be a complain to the United Nations Human Rights Committee.

The argument in brief would be that Canada's failure to meet its obligations under the Covenant has restricted access to higher education by Canadians with limited financial resources. This in turn would mean that Canada is in breach of article 26 of the International Covenant on Civil and Political Rights, which forbids discrimination on the basis of social origin, including economic resources.

While the committee does not have the power to make Canada change its policies, a decision in our favour would be an authoritative statement that Canada is in breach of its obligations under international law.

Such a declaration can have concrete effects: in 1977 the U.N. Human Rights Committee ruled on a petition by Sandra Lovelace that it was discriminatory and in violation of the International Covenant to deprive women of Indian status if they married non-Indians. Parliament subsequently amended the Indian Act to remove the offending provisions and the women affected regained their Band membership.

Goals

- 1. To seek a declaration that Canada has breached its obligations under the covenant
- 2. To involve our coalition partners in the education, labour and social justice sectors in the campaign.
- 3. To use such a declaration to further the federation's objective of eliminating financial barriers to postsecondary education.

Implementation

Federal-Provincial Congruency

Provincial components will be encouraged to support fundraising efforts to generate funds required to initiate the legal aspects of the case.

Research

Research will largely be undertaken by legal counsel engaged by the Federation.

FOURTH COMPONENT

Anti-Systemic Discrimination Campaign "Day Without Hate"

CONTEXT

The Federation is committed to challenging systemic discrimination, an endemic societal problem which contributes to compromised access to and quality of education for many students.

The work of the Federation reflects its ongoing struggle to confront hatred in its many forms. Since its founding, the Federation has mounted successful campaigns designed to raise awareness about and encourage progressive action on issues ranging from homophobia through sexism and racism to ageism.

For the past several years, however, the membership has favoured a more global approach to such campaigns, in the form of a general anti-oppression or anti-systemic discrimination campaign. As part of this commitment, on March 14, 1997, the Federation participated in **Day Without Hate**.

Founded in 1995 by local 8, the University of Winnipeg Students' Association, **Day Without Hate** fulfils many of the goals of previous anti-oppression campaign proposals accepted by the members. As the main focus of **Day Without Hate**, students' groups working on issues of human rights, social justice, and anti-oppression come together to share information amongst themselves, other students and the wider public, as well as to formulate strategies for working to fight hatred and create understanding on campus and beyond. Confronting and challenging discrimination is an ongoing struggle, one that requires united and creative efforts; an annual **Day Without Hate** campaign offers an appropriate and flexible venue for member locals of all kinds and members from many different backgrounds to work together for change.

Although Day Without Hate **is** just one day, one day which will not eradicate unfair discrimination or hatred, Day Without Hate has and can continue to serve as a step towards and a reminder that creating safe learning and living environments is all of our responsibilities.

The Federation will initiate a campaign, defined as follows:

CAMPAIGN GOALS

General Goals:

- 1. To implement a national Day Without Hate campaign on annual basis, on the second Wednesday of each year;
- 2. To raise awareness among members, campus and government policy-makers, and the Canadian public as to the links between inaccessibility to as well as compromised quality of post-secondary education and different forms of hatred on campuses and in curricula;
- 3. To contribute to challenging chilly climates on campuses, in which subtle forms of discrimination create barriers to access to post-secondary education;
- 4. To challenge systemic barriers to the creation of curricula inclusive of different cultural, social, economic, and racial/ethnic perspectives;
- 5. To encourage the Federation to continue to work for change by examining its own practices and prejudices as a student organization.

Specific Goals

1. To describe the spectrum of types and experiences of discrimination experienced in post-secondary institutions;

- 2. To provide tools, resources, and strategies for member locals to undertake activities on Day Without Hate:
- 3. To provide tools, resources, and strategies for member locals to undertake ongoing work on issues of hatred and discrimination on campuses and in the wider community;
- 4. To encourage member locals to entrench in their bylaws, policies, or structures, constituency representation on their boards and the allocation of resources to constituency groups on campus.;
- 5. To lobby campus and government officials for the following:
 - a. Physical accessibility to campuses and the eradication of chilly climate, in which discrimination occurs in many subtle forms;
 - b. The creation of equity/harassment structures, including equity/harassment officers, on campus;
 - Active encouragement for students from marginalized groups to take part in post-secondary education;
 - d. Affirmative action or employment equity in staff and faculty hiring practices;
 - e. Changes in course content, presentation, and curricula in order to make it more representative of diverse perspectives;
 - f. More adequate representation for students on University boards and committees.

IMPLEMENTATION

1. Federal-Provincial/Territorial Congruency

Because the Day Without Hate campaign is flexible, allowing for many different kinds of involvement, the main role at these levels will be to promote the goals of the campaign and to facilitate and provide resources for member locals. Congruency is not essential, provided that a coherent message of anti-hatred is expressed.

2. Research

Much of the research required for this campaign has been ongoing. As well, the Federation will rely heavily on members' experiences with issues of discrimination.

3. Membership mobilisation

Members are encouraged to hold events on their campuses including, but not limited to:

- a. teach-ins, or interactive political action seminars to critique and offer alternatives to traditional curricula:
- b. hands-on and role-playing workshops, with a focus on inviting representatives of campus and community groups to share their experiences;
- c. open mic nights, in which students are invited to speak about their experiences and ideas on issues related to the campaign;
- d. educational fora;
- e, demonstrations, rallies, or protests on specific issues related to the campaign;
- f. fair / symposium / festival / celebration of diversity;
- g. educational street theatre;
- h. educational classroom speaking:
- i. exposition of information tables;
- j. food fair, with an emphasis on foods from diverse cultures;
- k. video/film festivals.

Members are also encouraged to work in solidarity with groups working in areas of advocacy, support, education and service-provision, including, but not limited to the following: Aboriginal groups, students with disabilities, lesbian, gay and bisexual groups, environmental groups, multicultural groups, and women's groups.

Members are further encouraged to work towards long-term, meaningful solutions to systemic the many forms of systemic discrimination, including, but not limited to:

- a. scrutinizing and challenging campus and government policy-makers to change discriminatory aspects of the structures, policies, services, and employment practices;
- b. scrutinizing, challenging and changing discriminatory aspects of the structures, policies, services, and employment practices of their own member locals;
- c. taking positive action or providing advocacy support on issues of discrimination on campus and in the wider community.

3. National Awareness and Media Strategy

The membership will be educated through: posters; buttons; booklets/flyers; national media, provincial, and local work; a media/campaign kit for member locals, and; resource lists of types of organizations able to provide experience, and educational resources for the campaign; The general public will be educated through: buttons; public educational events; pledge-forms against hatred, and; national, provincial, and local media work.

It is agreed by the international student delegates that their primary concern is the lack of interest for the needs and concerns of international students. International student delegates are, however, grateful for the care, concern, encouragement and support that other delegates have shown toward international student issues.

International students have been, and still are, discriminated against by the government and postsecondary education administrations.

International students have been, and still are, discriminated against by the government even before they face the barriers within the visa applications process. International students face discrimination while they are studying in Canada because they have been, and still are, denied the right to work off campus, even though international students contribute significantly to the economy while studying in this country.

International students have been, and still are, discriminated against through the imposition of differential fees. These differential fees can be double or even triple the standard tuition fee. In this way, international students have been denied equal access to education and been used as a source of revenue.

As a result of the lack of representation of international students, there is insufficient awareness of and participation in student politics. It is recognised that the voices, interests and concerns of international students must be represented to promote international student participation.

The international students' constituency group would like the Federation to implement a campaign promoting international students' awareness of and participation in student events. It is hoped that this involvement will help to protect their rights, interests, needs and concerns when considered by the member locals.
