8. PRESENTATION BY STAFF RELATIONS OFFICER

Story said that she is the Staff Relations Officer and is the contact person in dealings with the staff on a formal level. She said that if delegates have any concerns about staff levels, participation or performance at the national general meeting they should address the concerns to the Staff Relations Officer. She said that the Collective Agreement, which is an agreement between the staff and the Federation as represented by the National Executive governs her role. She said that full participation rights are given to staff and protected by the Collective Agreement. She said that staff have the right to speak in plenary and in committees. She said that staff provide the history, context and continuity the membership requires to make informed decisions. She said that the Collective Agreement is a public document and delegates have the right to access it.

Story then introduced the staff complement.

9. INTRODUCTION OF HARASSMENT ADVISORS

Story said that the harassment policy is contained in the Policy Manual and the Federation hires harassment advisors to be on site at the national general meetings. She encouraged delegates to read the harassment policy and familiarise themselves with it. She said that two harassment advisors will be on call throughout the entire general meeting and are available 24 hours a day. She said that both Florence Loh and Tara Connolly have excellent experience in harassment issues. She said that returning delegates would be familiar with Tara who has acted as harassment advisor at a number of general meetings.

Connolly said that she has experience with crisis-line work and shelter work in addition to her previous expereince as a harassment advisor at Federation meetings. She said that the role of the advisors is to help anyone negotiate their way through the harassment complaint process if they chose to access it. She said that there are other aspects to the work, including functioning as a peer listener. She said that it gives delegates an opportunity to vent productively in a confidential setting in an effort to clarify the issue. She said that the intense atmosphere may overwhelm delegates and the advisors are present to advise on ways to handle this stress.

Florence Loh said that she had experience with the crisis line and crisis intervention and the immigrant community in Ottawa. She said that she is available any time and delegates should be comfortable approaching her.

Connolly said that national general meetings are a different world. She said that the quality of interactions can change once delegates arrive at the meetings. She said that delegates attend the meeting to pursure a political agenda and to express the views of the local and personal opinions. She said that within this context delegates should examine their goals and what is achievable and their limitations. She said that there are successes and failures which are defined by the individual delegates. She said that she is not in a position to define the successes or failures. She said that debates can disintegrate into personal attacks. She said that it should not happen at the meeting if delegates think before speaking. She said that the personal is political and everyone should remember that attacking an idea can also be interpreted as attacking a core belief. She said that delegates should take responsibility for challenging ideas and recognise the potential impact it may have upon others. She said that challenging is a catalyst for change. She said that silence is also a message.

> C. The Federation supports the creation of Pan-Canadian Principles, which would ensure a high quality, publicly funded and publicly administered, fully accessible, comprehensive and portable system of post-secondary education in Canada. The Federation defines the above term as follows:

Public Administration: A Post-Secondary Education system that is nationally planned and governed on a not for profit basis;

Accessibility: Post-Secondary Education would be available to all individuals with the capacity and desire to be educated and/or acquire skills, irrespective of their background; post-secondary institutions would be free of all user fees. A system of national grants would be available to students in need:

Comprehensiveness: A public education system designed to ensure a complete range of options; university, community colleges, professional and vocational training, distance education and continuing and adult education;

Transferability: Credits acquired would be transferable between all institutions in the country: all barriers between different types of institutions and provinces would be eliminated. This would not involve the complete standardisation of curricula;

Mobility: All residency requirements for eligibility for student grants and awards would be eliminated.

Funding of post-secondary education for the province of Québec must be subject to negotiations between Québec and the federal government. Until the agreeable settlement of the Québec/Canada relationship, the establishment of pan-Canadian principles must take into account the uniqueness of Québec as well as the Aboriginal Peoples.

The Federation supports the Council of Ministers of Education Canada and supports increased funding to the Council in order to allow for its equal participation with the federal department of Post-secondary Education and Research.

National Executive Representative and Committee Chairperson Jessica Squires said that the motion calls for the replacement of the Federal Ministry for Higher Education in the policy manual with a policy on postsecondary education. She said that it is a combination of several previously existing policies. She said that it is also an attempt to change the policy to read "post-secondary education" not higher education. She said that the text is based on the Blueprint for Access:Strategy for Change and summarizes the Federation's vision for post-secondary education in Canada.

A delegate from Local 68 Becky McFarlane said that she is opposed to the motion. She said that the government cannot deal with issues of post-secondary education. She said that establishing another level of bureaucracy will be completely useless. She said that she is opposed to every and any level of government which deals with post-secondary education.

He said that defining a system of governance without defining the rights of the people who will be under the system is flawed. He said that democratic decisions made by students and workers does not automatically lead to a better system of government.

Adelegate from Local 54 Rabkin said that she does not use the word democracy in the amendment to mean a voting procedure or a system of government. She said that it defines a way of participating on campuses and what it would mean to be a student. She said that when students enter classrooms or meetings they are entering an undemocratic structure. She said that the amendment is intended to address who are the legitimate stakeholders on campuses. She said that it is not about governance but about who develops the rules and who has a legtimate voice on campus.

The Federation believes that conditions of poverty have an effect on access to education, and on the quality of education while in the system. Therefore the Federation recognises the political responsibility of students to keep personal poverty in perspective, recognising personal privilege while also working against poverty in general.

A. Minimum Income Levels

The Federation recognises that the current levels of various forms assistance has led to a need for combining two or more sources of assistance in order to survive. The Federation believes it should not be necessary to combine forms of assistance, and calls for increased levels of assistance in all forms.

- Recognises that fiscal decisions by governments which convert public debt into private debt and poverty, comprise a debt trap which widens the gap between Canadians living in poverty and those living in comfort;

- Supports the use of National Council on Welfare low-income cut-off rates to establish levels of assistance and to determine the effectiveness of programs; and
- Supports the development of criteria based on National Council on Welfare low-income cut-off rates to determine a minimum income level for members of constituencies such as students, sole-support parents, and other situations with additional expenses associated with them.

B. The Common Experiences of Poverty

The Federation recognises that similar perceptions exist of those on social assistance and those on student assistance, such as the perception that they are "receiving a handout," and the opinion that they are bad money managers with too much time on their hands. In addition, regressive aspects of the social assistance and unemployment insurance programs are echoed in the student loan program: the clawback of assistance based on employment income earned while receiving assistance is present in all three programs. Therefore, in solidarity with individuals receiving all forms of government assistance, the Federation:

- Opposes the stereotype of those on forms of assistance as lazy or inferior;
- Opposes the claw back of assistance based on earnings while receiving assistance through government social programs; and
- Opposes the deliberate setting of assistance at levels well below the low-income cut off rates determined by the National Council on Welfare.

C. Student Poverty and Student Health

The Federation:

- Recognises the cycle of poverty and stress which lead which lead to ill health and more stress;
- Recognises access to health services as an essential aspect of quality education;
- Supports full, free and accessible health and support services provided by the institution, including counselling services; and
- Recognises professional and quality peer support services, while essential, do not eliminate the need for professional services.

The North American Free Trade Agreement between Canada, the United States and Mexico, took effect January 1, 1994.

Asia Pacific Economic Cooperation, initiated in 1989, is comprised of Asia Pacific member countries including Canada, the United States and Mexico. The goal of Asia Pacific Economic Cooperation is to create a free trade zone in the Asia Pacific by 2020. Unlike the Canada-United States Trade Agreement and North American Free Trade Agreement, Asia Pacific Economic Cooperation was not designed to negotiate a legally binding agreement, but as individual action plans between members. These can be introduced on a piece meal basis without legislative approval, and therefore without public consultation or discussion.

The Multilateral Agreement on Investment was initiated in 1995 by the member countries of the Organisation for economic Cooperation and Development as a set of rules governing trade and investment. The Multilateral Agreement on Investment removes barriers to the global mobility of capital and allows trans-national corporations and other powerful investors the unfettered right to buy, self and relocate at their discretion.

The Federation supports the immediate abrogation of the Canada-United States Free Trade Agreement and the North American Free Trade Agreement.

The Federation opposes Canada's participation in Asia Pacific Economic Cooperation and the Multilateral Agreement on Investment.
