Be it resolved that the following policy be adopted:

The Federation supports the establishment of an autonomous "national" aboriginal student organisation fully independent of the Federation.

# a. Policy Proposal on Freedom to Choose Full or Part-Time Status

Local 84/

Be it resolved that the following policy be adopted:

# Freedom to Choose Full or Part-Time Status

The Federation recognises that the elimination of post-residency fees and the creation of continuous enrolment schemes significantly increase the cost of obtaining post-secondary education.

The Federation condemns any post-secondary institutional policies which have the effect of lowering of taking away a student's freedom to choose full or part-time status.

# b. Proposal to Amend the Declaration of Students' Rights

#### 99/11:N03 MOTION TO AMEND POLICY

Local 44/

Be it resolved that the Declaration of Students' Rights be repealed and replaced with the following:

The following are declared as undeniable rights of all students globally:

The Right to an Education

The right to an accessible, high quality education that it free of all barriers.

The Right to Organise

The right to incorporate unions free of the institution's administration including the right to have fees collected and remitted by the administration when properly authorised by the student organisation, the right to participate in political actions without fear of recrimination, and the rights to sufficient on-campus office space free of charge.

#### The Right to Employment

All students have the right to employment at a fair and equitable wage including the right to equal pay for work of equal value, the right to education leave with job security, and the right to be paid for labour which is performed as part of their studies.

#### The Right to Justice in Educational Community

All student have the right to participate as full voting members in all levels of all academic decision making bodies, to be informed of the evaluation procedures and criteria to redress all grievances, to copyright to all original work produced by the students, to participate in the formulation of objective course and instructor evaluations, to transfer credits of equal status from one post-secondary institution to another regardless of province or territory, and to a safe and healthy environment free of harassment.

#### The Rights of Cultural and Linguistic Minorities

Cultural and linguistic minority student groups have the right to immersion programmes in their native languages and one of the official languages, to have their language(s) taught at post-secondary institutions, and to have programmes, clubs, and organisations specific to cultural and linguistic minorities.

#### The Right to Services

All students are entitled to fundamental services including the right: to affordable housing; to free, accessible, quality child care facilities; to adequate health, dental, and counselling services; to control of their own body; to safe, reliable, birth control and family planning information; to free, accessible public transportation; and the right to take part in the development and management of student services.

#### c. Policy Proposal on Governance of Post-Secondary Institutions

# 99/11:N04 MOTION TO ADOPT POLICY

Local 91/

Whereas the Federation currently has policy calling for the democratisation of the governing structure of post-secondary education institutions;

Whereas most student do not know that the governance structures of their institutions are and have no idea what democratising them would mean; and

Whereas public outreach on this issue will be facilitated by a policy that is easy to understand and make intuitive sense; therefore

Be it resolved that the following policy be adopted:

#### Governance of Post-Secondary Institutions

Representatives in the governing structures of post-secondary institutions should be elected by the students and workers in their respective communities in the following ratios: 1/3 students, 1/3 professors and 1/3 support staff.

#### d. Proposal to Eliminate the Use of "National"

Whereas the Canadian state rules over many nations including but not limited to several First Nations, the nation of Québec and a primarily English-speaking Canadian nation; and

Whereas the Federation's use of the term "national' to describe its executive, its committees, its staff et cetera, implies the existence of only one single and indivisible national unit called "Canada"; therefore

Be it resolved that with the exception of Standing Resolutions #17 and #18 which must be discussed by the National Aboriginal Caucus and the National Graduate Council, the term

"national" be replaced in all bylaws, standing resolution, issues policy and operational policy with the term "federal"; and

Be it further resolved that the extensive consultation procedure required as per Bylaw XV be undertaken at the provincial and federal levels with the aim of amending the preamble of the policy manual so that its terminology will be consistent with that of its Bylaws, Standing resolutions, Issues policy and Operational policy.

# e. Proposal to Amend Federation Membership Fees

#### 99/11:N06 MOTION TO AMEND BYLAWS

Local 91/

Whereas high school and Collèges d'enseignement générale et professionnel students have much less disposable income than college and university students;

Whereas high school and Collèges d'enseignement générale et professionnel students are not disposed to spend as much on membership dues as college and university students because there are very few user fees associated with studying at these institutions (which makes Federation membership fees appear more burdensome);

Whereas high school and Collèges d'enseignement générale et professionnel students are less likely to benefit from International Student Identity Card discounts because they travel less than collège and university students:

Whereas the current fee structure in Bylaw I constitutes a barrier to bringing high school and Collèges d'enseignement générale et professionnel students into the Federation as full members; therefore

Be it resolved that Bylaw I, Section 2 a iii, be amended to read as follows:

Notwithstanding Section 2.a.iv of Bylaw I, the fees for full member local associations shall be:

- a. \$3.00 per semester, or \$6.00 per academic year, per local college and university association individual member of the Canadian Federation of Students/Canadian Federation of Students-Services, pro-rated as per the policy of the member locals association;
- b. \$1.50 per semester, or \$3.00 per academic year, per local Collèges d'enseignement générale et professionnel and high school association individual member of the Canadian Federation of Students/Canadian Federation of Students-Services, pro-rated as per the policy of the member local association; and all full member must also pay the applicable provincial component fee.

#### f. Proposal to Allocate Additional Resources to Strike 2000

Local 91/

Whereas the amount of money currently being spent on what ought to be one of the largest student actions in Canadian history is pitiful and embarrassing; therefore

Be it resolved that \$30,000 in new funding be devoted to the production of campaign materials;

Be it further resolved that \$12,000 be spent on the hiring of two campaign workers on a temporary basis to mobilise for Strike 2000 in the months ahead; therefore

Be it further resolved that \$20,000 be distributed to provincial and local strike funds and legal defense funds; and

Be it further resolved that \$20,000 be put into a transportation fund that can be drawn upon by member locals to rent vans and buses to get protestors and placards together for the first day of the strike.

#### g. Proposal to Contribute Resources to Access 2000 Organising

#### 99/11:N08 MOTION

Local 91/

Whereas all campaigns on education ad education policy have an extremely significant provincial component because provincial governments have primary responsibility for education spending and education policy;

Whereas provincial concerns cannot all be addressed in campaign materials done at the national level: and

Whereas many of the smaller provincial components of the Federation lack the resources needed to provide the provincial-specific campaign materials that are required; therefore

Be it resolved that all of the budget line items for the production and distribution of campaign materials be divided into two equal parts. One half of the money will be for the production and distribution of national campaign materials. The other half of the money will be remitted to the provincial components for the production and distribution of province-specific campaign materials. Money remitted to the provincial components will be divided between the provincial components on the basis of the number of full members in each province.

#### h. Proposal to Censure Members of the National Executive

#### 99/11:N09 MOTION

Local 91/

Whereas the November 1998 national general meeting directed the National Executive to implement a campaign to mobilise students for a Canada-wide strike in February 2000;

Whereas student strikes (such as the Mexican student strike that after 5 months is still ongoing at the time this motion is being drafted) are a way for students to organise and manage their own campuses, education and daily activity in a democratic and grassroots manner that contrasts directly with the normal undemocratic organisation of our educational institutions, economy, and society in general;

Whereas this push to encourage local grassroots actions coordinated at the Canada-wide level constitutes an attempt to bear the power of wide-spread self-organised resistance to reductions in accessibility of education;

Whereas this kind of self-organised resistance is the only thing that makes the lobbying efforts of our federal and provincial representatives anything more then mere public posturing;

Whereas the National Executive has largely focussed its efforts on an Access 2000 campaign in lieu of a Strike 2000 campaign;

Whereas the Access 2000 campaign has focused largely on the production of materials that publicise the Federation's lobbying proposals without offering any information, suggestions (i.e forming a strike committee or organising strike votes on your campus) or concrete support of local efforts to organise for such laudable goals; therefore

Be it resolved that the National Executive be formally censured by the general assembly for its failure to move forward in mobilising for Strike 2000; and

Be it further resolved that the Strike 2000 campaign be fundamentally re-oriented to encourage local organising and mobilising efforts that build in a concrete way for a Canadawide student strike in February 2000. These efforts should include but not be limited to the immediate mass production and distribution of posters, leaflets, buttons, stickers, and other campaign materials that prominently feature the fact that the Federation is mobilising for a strike in February 2000. These materials should be distributed to Federation locals and other interested parties by no later than December 20<sup>th</sup>, 1999. There must be a minimum of two full time campaign workers occupied exclusively with mobilising for Strike 2000 in the months ahead.

The Federation denounces the federal funding policy entitled the Post-Secondary Student Support Programme. The Federation views this document as a governmental social policy that is sexist, racist, inaccessible and exclusionary.

The Federation supports the creation and maintenance of Aboriginal resource centres and Aboriginal student services, that are by, and for, Aboriginal people.

# b. Policy Proposal on Civil Liberties and Human Rights

#### 99/11:N11 MOTION TO ADOPT POLICY

Be it resolved that the following policy be adopted:

#### Civil Liberties and Human Rights

The Federation supports Amnesty International and other campaigns and organisations whose mandate is to fight for the release of political prisoners.

#### c. Policy Proposal on College Issues

#### 99/11:N12 MOTION TO ADOPT POLICY

Be it resolved that the following policy be adopted:

#### College Issues

The Federation recognises the value of private sector training as a complement to post-secondary education, however strongly opposes it as a replacement for training in colleges.

#### d. Policy Proposal on Democracy in Post-Secondary Education

#### 99/11:N13 MOTION TO ADOPT POLICY

Be it resolved that the following policy be adopted:

#### Democracy in Post-Secondary Education

The Federation supports member associations working towards assuming complete control of the electoral process that elects students to committees at all levels in post-secondary institutions.

The Federation strongly opposes discriminatory zoning by-laws which limit student access to housing and municipal lodging by-laws whose measures do not clearly reflect the reality of student housing preconditions.

# h. Policy Proposal on International Issues

#### 99/11:N17 MOTION TO ADOPT POLICY

Be it resolved that the following policy be adopted:

#### International Issues

- i. The Federation condemns all forms of apartheid, and supports all students in their struggle for democracy and a free and just society:
- The Federation condemns any actions of torture afflicted upon students and any attempt to infringe their human rights in China and elsewhere;
- iii. The Federation condemns the illegal military government in Burma and enjoins all parties to discontinue any association with that government;
- iv. The Federation recognises that rights of self-governance for the people of East Timor and strongly condemns the continuing repression of student and other East Timorese by the Indonesian government.

#### i. Policy Proposal on International Students' Issues

Be it resolved that the following policy be adopted:

#### International Students' Issues

The Federation supports the right of international students to be employed in post-secondary institutions, including student government organisations and that this right be upheld.

# j. Policy Proposal on Labour and Working Conditions

Be it resolved that the following policy be adopted:

#### **Labour and Working Conditions**

The Federation supports policies, procedures and implementation strategies that promote equal pay for work of equal value.

The Federation supports the concept of paid educational leave as outlined in the relevant Canadian Labour Congress policy.

# k. Policy Proposal on Transgendered, Lesbian, Gay and Bisexual Issues

#### 99/11:N20 MOTION TO ADOPT POLICY

Be it resolved that the following policy be adopted:

#### Transgendered, Lesbian, Gay and Bisexual Issues

The Federation reaffirms support for the inclusion of same-sex couples within the legal definition of "family" and calls for the extension of all benefits including the right to adopt to same sex couples. The Federation supports the right of same sex couples to adopt their partner's children. The Federation believes that both parents should have equal rights, obligations and responsibilities to their children.

#### Women's Issues

The Federation call for an end to the vocational streaming of students, according to gender, at high school and post-secondary education levels.

The Federation supports, in principle that, as a condition of their broadcast licenses, both corporate and community radio stations and broadcast networks must comply with the Canadian Radio-Television and Telecommunications Commission (CRTC) Task Force on Sex Stereotyping recommendations and guidelines.
