COPY OF RESOLUTION

The following is a copy of a special resolution passed in . accordance with the by-laws of the Society on the 8th day of . September, 1985:

"Resolved that the by-laws of the Society be amended to read as follows:

- \checkmark 1.2 (ii) (a) Prospective membership status has a duration of eighteen months and does not lapse until review at the next general meeting.
- 28.4 There shall be no more than two (2) voting executive committee members from any member local association. The chair shall not be included.
- ./8.5 The candidates for the at large positions on the executive committee must be authorized by a member local association as a delegate to the general meeting of the Federation at which elections are held and be a member of the local association; or candidates must have been a member of the executive committee up to the time of the meeting at which elections are held, provided that such executive members are members of the local association. The chair shall be eligible to run for a second term; the above regulations shall not apply.
- 8.8 ... two (2) consecutive terms on the executive committee as an 'at-large' member shall be eligible for re-election ... (SEE NTACHED
- v 9.4 The women's liaison shall be elected by the women's caucus and hold office for one (λ) year from the date of election... (SEE ATTACHED SHEET)
- $\sqrt{13.5}$ The first item of the first meeting of the executive committee shall be to elect a deputy chairperson and staff ρ CHANGE OF BULANDS EFF: 20 00 840 adjournment of the general meeting.
 - 14.4 The executive committee and the members of the executive committee may from time to time delegate to other members of the executive committee and staff of the Federation their duties except the casting of votes.
