# SOCIETY ACT

I HEREBY CERTIFY that CANADIAN FEDERATION OF STUDENTS-PACIFIC REGION has pursuant to the Society Act altered its purposes and that its purposes now are:

- 2. (a) To organize students on a democratic, co-operative basis in advancing students' interests, and in advancing the interests of the students' community;
