AFFIDAVIT

I, the undersigned, FEHR MAROUF domiciled and residing at 109, Lewis, in the City Westmount and District of Montreal, do solemnly declare and state:

- 1. The 24th of July, 2007, I slept at the offices of the Canadian Federation of Students Quebec, at 1500 de Maisonneuve Ouest, room number 405.
- 2. That decision was made by Nina Amrov, Chairperson of the CFS-Q Mahdi Altalibi, Deputy Chairperson of the CFS-Q, Patrice- Blais, Graduate Students` Association representative to CFS-Q, following the firing of George Soule that day, former employee of the CFS-Q, who had refused to turn over his keys.
- 3. The morning of the 25th of July, 2007, around 7:30 AM, George Soule entered the offices and was surprised to see me. He then said he needed to take the SIM card from the office cellphone which he had been using up to the day of his firing.
- I then asked him to leave his keys in the office, as I had been asked to do by Mahdi Altalibi, and he refused.
- 5. That same day, the locks were changed again, to ensure that the former employee no longer had access to the premises.
- 6. The night of Friday, August 3rd, 2007, I entered the offices as normal, and the locks were still functioning.
- 7. The morning of Monday, August 6th, 2007, I attempted to enter the offices with Mahdi Altalibi, but the locks had been changed sometime during the weekend.
- 8. We proceeded to notify the police, and we called a locksmith to regain access to the premises.

- 9. After re-entering the office, we discovered that the cheque book was missing, and called the police once again to file a report.
- 10. From that point on it was decided by Nina Amrov, Mahdi Altalibi and Patrice Blais that a 24-hour watch would be instituted, and I would take on the night shift, sleeping at the office every night.
- 11. On the night of Wednesday, August 8th, 2007, around 10:00 PM, I was at the offices with Alexander Winterhalt and Aaron Donny-Clarke when Erica Jabouin, Noah Stewart-Ornstein and George Soule arrived at the door with a locksmith.
- 12. I was able to recognize them by looking through the peep-hole of the door.
- 13. While looking out through the hole, I heard the locksmith ask them if they were sure they were allowed on the premises.
- 14. When they assured him, I heard and saw him place something against the lock, at which point I knocked on the door. I then told them that if anyone touches the lock on the door, the police would be called.
- 15. At that point, the locksmith stopped, and I didn't see him at the door any longer.
- I called Mahdi Altalibi and asked him to call the police and come to the office as soon as possible.
- 17. I saw the police arrive in the street downstairs, I also saw the locksmith talk to the police until Mahdi Altalibi arrived, at which point the locksmith walked away and remained at a distance for the remainder of the events.
- 18. Mahdi Altalibi began speaking to the police officers, and then I saw George Soule and Erica Jabouin approach the police car and talk to the police.

- 19. After ten minutes, I decided it was best for me to join Mahdi Altalibi and help explain the situation to the police, but we decided we needed to take precautions before I left, despite the fact that we could see no one in the hall through the peep-hole.
- 20. Alex Winterhalt and Aaron Donny-Clarke stood at the door with me in preparation. Alex Winterhalt unlocked the door and opened it for me, at which point I attempted to run out, but Noah Stewart-Ornstein had been crouching at the door and lunged at me.
 Aaron Donny-Clarke pushed me through the door and both me and Noah Stewart-Ornstein fell to the floor. At this point I heard the door slam and lock behind me.
- 21. Both me and Noah Stewart-Ornstein went down to see the police.
- 22. All the above facts alleged in this affidavit are true.
