AFFIDAVIT

I, the undersigned, ALEXANDER WINTERHALT domiciled and residing at 1456, St-Marc Appartment 2B, in the City and District of Montreal, do solemnly declare and state:

- I live very near to the office of the Canadian Federation of Students Quebec, which is located at 1500 de Maisonneuve Ouest, room number 405.
- In late July and the beginning of August, 2007, I stopped by the office on numerous occasions.
- On the afternoon of Monday, August 6, 2007, I dropped by the office and was told that the locks were changed yet again.
- Aaron Donny-Clarke explained the situation to me; that a 24-hour watch was now necessary at the office to ensure that another incident wouldn't occur.
- 5. I went home that evening to have supper, and when I returned Fehr Marouf was in the office. I stayed late in the office with him, and when I returned home he stayed.
- On Tuesday, August 7th, 2007, I once again dropped by and stayed late, leaving Fehr Marouf in the office when I left.
- 7. On Wednesday, August 8th, 2007, I was staying with Aaron Donny-Clarke and Fehr Marouf in the office, when we heard some noise in the hallway around 10:00 PM.

- 8. Fehr Marouf went to look through the peephole, and informed us, quietly, that there were people at the door, including someone whom he recognized as the locksmith.
- 9. I heard a tool at the door, and heard Fehr Marouf knock at the door and explain that if anyone touches the lock, the police would be called.
- 10. Fehr Marouf was on his cell phone and informed us that he was contacting Mahdi Altalibi, Deputy Chairperson of the CFS-Q.
- 11. A minute or two later, I looked through the peephole, and clearly recognized Noah Stewart-Ornstein, whom I had known for three years. I also saw another person at the door.
- 12. After a while, I looked out the window and saw Mahdi Altalibi and other people speaking to the police in the street. I did not see Noah Stewart-Ornstein downstairs at this point.
- 13. Later on, it was decided that Fehr Marouf needed to go down to help Mahdi Altalibi explain to the police officers, but that we needed to be careful as he exited.
- 14. We decided that I would open the lock and the door, and close it quickly when Fehr Marouf exited. Aaron Donny-Clarke and I stood at the door as Fehr Marouf prepared to exit, but as I opened the door and Fehr Marouf tried to get out, there was an obstruction at the door.
- 15. I felt the door being forced open from the outside and Fehr Marouf could not get out, until Aaron Donny-Clarke gave him a push, at which point I slammed and locked the door and clearly heard Noah Stewart-Ornstein shouting.

- 16. Aaron Donny-Clarke and I remained in the office, and stood at the window, where I saw Fehr Marouf, Mahdi Altalibi, Noah Stewart-Ornstein and others speaking to the police.
- After a while, Mahdi Altalibi, Fehr Marouf and others came back up. We stayed in the offices very late, and eventually I left to go home, but Mahdi Altalibi, Fehr Marouf, and others remained.
- 18. All the above facts alleged in this affidavit are true.
