OATH AND SAY:


1. I am a former President of Kwantlen College Student Association (now Kwantlen University College Student Association) (herein referred to as "KCSA") and as such have personal knowledge of the facts and matters herein deposed to save and except where the same are stated to be made upon information and belief and where so stated I verily believe the same to be true.
2. That I served as President of KCSA during the 1990-1991 school year.
3. In January 1991 the Executive of KCSA were presented with a petition requesting that a student referendum be held on KCSA's membership in the Canadian Federation of Students.
4. The Executive of KCSA passed a motion to hold the student referendum on September 25, 1991.

5. The Executive of KCSA sent a written notice to both the B.C. and National offices of the Canadian Federation of Students in January 1991.
6. Attached hereto and marked Exhibit "A" to this my Affidavit is a copy of the written notice addressed to the Canadian Federation of Students dated January 29, 1991 with my signature as President of KCSA. The said notice was sent by way of registered mail to the Canadian Federation of Students.
7. Representatives of the Canadian Federation of Students campaigned during the weeks prior to the referendum vote. On the day of the vote representatives of the Canadian Federation of Students attended with scrutineers.
